Aptos Tournament - February 14, 2024 Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

<u>Overview</u>: The February 14, 2024, Aptos Tournament (the "Promotion") allows eligible participants to play a series of chance and skill-based games ("Promotion Play"), where individual winners from each round can advance to the next round and losing Participants will be eliminated. Promotion Play will continue until there are five remaining Participants who will be deemed the winners of the Promotion. The top five finishing Participants will each be entitled to receive \$200 of Wrapped USDC on Aptos as a prize. Odds of winning depend on the number of eligible Participants that enter the Promotion, as well as skill in the skill-based games. There is a limit of 100,000 Participants for the Promotion. There is no cost to enter the Promotion. Network gas costs to participate in the Promotion will be paid for by the Sponsor.

<u>Promotion Period</u>. The Promotion begins at approximately 15:00 Pacific Time on February 14, 2024, when individuals will be allowed to register; the Promotion ends when the Promotion play is completed and there is one remaining Participant (the "Promotion Period"). Promotion Play is expected to start within approximately 180 minutes after the beginning of the Promotion Period, approximately 18:00:00 Pacific Time. Sponsor's database computer shall be the official timekeeping device for the Promotion.

Eligibility. Promotion is available only to those who are 18 or older at the time of entry. Promotion is limited to the first 100,000 Participants who register. In order to receive a prize, a Participant must have an account on the Aptos blockchain network and register for the Promotion using the Identity Connect service. "Restricted Persons" are ineligible to participate in the Promotion. Restricted Persons are those who are subject to sanctions administered or enforced by any country or government or otherwise designated on any list of prohibited or restricted parties (including but not limited to the lists maintained by the United Nations Security Council, the U.S. Government, the European Union or its Member States, or other applicable government authority) or a citizen or organization or resident in a country or territory that is the subject of country-wide or territory-wide sanctions (including, without limitation, Cuba, Democratic People's Republic of Korea, the Crimea, Donetsk, and Luhansk regions, Iran, or Syria). For clarity, if you are a Restricted Person, you are prohibited from registering for the Promotion. Employees and their immediate family members (parents, children, siblings or spouse, regardless of where they live, and persons living in the same household, whether related or not) of Sponsor, its affiliates, and any other entities directly associated with the operation of this Promotion are not eligible to p Participation by persons who do not meet the eligibility requirements (including all requirements with respect to age and residence) is grounds for disqualification. Only one (1) registration is permitted per person. Multiple Participants are not permitted to share the same Identity Connect Account. Any attempt by any person to register for the Promotion more than one (1) time is grounds for disgualification. The use of any scripts, computer programs, robotic repetitive, macro, automatic, programmed or similar automated entry methods or agents to register or otherwise seek to participate also is grounds for disqualification. Void where prohibited by law.

<u>How to Participate</u>. To participate in the Promotion you must register at <u>www.aptostournament.com</u> during the allotted time and create a web3 wallet using the Identity Connect service. Promotion Play will begin the earlier of 1) the Promotion receiving the maximum number of Participants; or 2) approximately 180-minutes after the start of the Promotion Period. Promotion Play will consist of a series of chance and skill-based games, where winning Participants from each round will advance to the next round and losing Participants will be eliminated from Promotion Play.

Participants will be required to sign blockchain transactions as they play the games and progress in the tournament but there is no cost to participate and network gas costs will be paid for by Sponsor. In some cases, Participants may automatically advance to the next round of Promotion Play without playing if there are an odd number of players/Participants.

The number of games played or rounds of the Promotion may vary based on the number of Participants. The winning Participant of Promotion Play will be the last remaining Participant. Promotion Play may include some combination of the games listed below. Promotion Play may include consecutive rounds of the same game. Some of the games described below may not be part of Promotion Play.

Rock-Paper-Scissors

Two Participants will be matched up against each other for a game of rock-paper-scissors. Each Participant will choose to play either rock, paper, or scissors (collectively, "Items") by choosing the corresponding Item. Once play starts, each Participant will have a minimum of 10 seconds to pick an Item to play. If a Participant fails to play an Item in the allotted time they will be eliminated from Promotion Play and their opponent will advance to the next round. If neither Participant picks an Item within the allotted time, both Participants will be eliminated from Promotion Play. Once both Participants have chosen an Item, they will see the Item the other player has chosen and the winning player will advance to the next round of Promotion Play. Rock defeats scissors, scissors defeat paper, and paper defeats rock. If the competing Participants pick the same Item, they will have an opportunity to play again until a winner of the match is determined.

Trivia

Once a round of Trivia starts, Participants will be shown a fact-based trivia question with either two or four possible multiple choice answers. Each Participant will have a minimum of 10 seconds to choose the correct answer. Every Participant that chooses the correct answer within the allotted time will advance to the next round of Promotion Play. Participants who choose an incorrect answer or fail to answer the question within the allotted time will be eliminated from Promotion Play.

Aptos Wheel

Participants will be randomly grouped into games consisting of four Participants. Each Participant will be shown a wheel with twelve numbered sections. Each Participant will be randomly assigned a different quadrant of the wheel consisting of three numbered sections, and have a minimum of 10 seconds to select one of the three numbered sections. Once all the

Participants have selected a section of the wheel, one of the twelve sections will be selected at random by the game. If any of the Participants chose the section of the wheel randomly selected by the game, that Participant will be eliminated from Promotion Play. Participants who fail to select a section of the wheel within the allotted time will also be eliminated from Promotion Play.

Death Box

Participants will be randomly grouped into games consisting of four Participants. Each Participant will be shown a box divided into four quarters. Each Participant will be given a minimum of 10 seconds to choose a quarter of the square. Participants can choose the same quarter. One quarter will be selected at random by the game and any Participant the same quarter chosen by the game will be eliminated from Promotion Play. Participants who fail to select a quarter within the allotted time will also be eliminated from Promotion Play.

<u>Prize</u>. The top five finishing Participants of the Promotion will each be eligible to receive \$200 of Wrapped USDC on Aptos as a prize.

<u>Odds</u>. Odds of winning depend on the number of Participants and skill in any skill-based rounds of Promotion Play. Many may enter, only a few can win.

<u>Winner Notification: Claiming Prizes</u>. Following the end of Promotion Play, each winning Participant will immediately be notified via the Promotion Play website where they will be able to claim their prize by entering an Aptos Account address to which the prize will be transferred. Each winner must claim their prize within one hour of the end of Promotion Play. Any potential winner may be required to sign a declaration of eligibility and a liability and publicity release where not prohibited by law. Failure to comply when requested is grounds for disqualification. If any potential winner is deemed a minor in their place of residence, a parent or legal guardian must sign any required documents.

<u>Binding Terms and Conditions</u>. By participating in the Promotion, you agree to be bound by these specific terms and conditions for this Promotion as well as Sponsor's <u>General Terms for</u> <u>Promotions</u>.

Sponsor further reserves the right to correct typographical errors and to modify the Official Rules to reflect non-material updates to the Promotion.
- 3. Entries and Request Forms. Entries and request forms ("entries") will not be acknowledged or returned. No late, illegible, incomplete, or altered entries will be accepted. Proof of submission of an entry does not constitute proof of receipt. Any person who attempts to participate under multiple identities, or uses any scheme, device or artifice to submit multiple entries in violation of any limitation will be disqualified. In case of dispute, an on-line entry will be deemed made by the authorized account holder of the email account used to submit the entry. The "authorized account holder" is the natural person who is assigned to either (a) an Aptos blockchain account associated with entry into a Promotion; or (b) where applicable, an e-mail address by an Internet access provider, on-line service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address or administering accounts on behalf of such provider.
- 4. <u>Submissions</u>. Participant hereby grants Sponsor and its licensees an irrevocable, unlimited, worldwide, license and right to reproduce, publish, use, modify, edit, excerpt, and publicly display and perform the Submission in any way, in any and all media, now known or created in the future, and for advertising, marketing, public relations, and promotional purposes, without any right to review or approve any use or changes, and without consideration to the Participant or any third party.
- SUBMISSIONS ARE THE VIEWS OR OPINIONS OF THE PARTICIPANT AND DO NOT NECESSARILY REFLECT THE VIEWS OF SPONSOR. Any Submission will be deemed made at the direction of the Participant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act.

- 5. Prizes or Promotional Items. All prizes or promotional items are provided "AS IS" without any warranty of any kind from Sponsor. All prizes and promotional items are subject to availability and other restrictions. Prizes and promotional items are non-transferable and no cash redemption or substitution allowed, except at Sponsor's sole and absolute discretion. Sponsor reserves the right at any time to substitute any prize or promotional item or a component thereof with an item of equal or greater value, including, without limitation, at the Sponsor's sole discretion, a cash award, if the advertised item has become unavailable. If gift cards or event tickets are included, they are subject to the terms and conditions associated with the gift cards or tickets. In no event will more than the stated number of prizes or promotional items be awarded. being provided to the Sponsor and not to any Social Media Channel. Social Media Channels are completely released of all liability by each Participant in the Promotion. Any questions, comments or complaints regarding the Promotion must be directed to the Sponsor and not the applicable Social Media Channel.

- 12. Release and Indemnification.
